4. FIRST AID MEASURES

Inhalation: Remove victim from exposure, avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until recovered. Seek medical attention.

6. ACCIDENTAL RELEASE MEASURES
